SUBJECT:- BID EVALUATION RESULT OF TENDER ENQUIRY DATED 09.04.2016

The sealed bids based on item wise rates for the purchase of 50 Workstations for IT Lab and 03 Wooden Cabinets for the Bureau's scheme titled "Strengthening of IT Infrastructure and Development of Online Databases for Bureau of Statistics (BoS) Punjab" for the Financial Year 2015-16 were invited in accordance with the single stage two envelop procedure laid down in Rule-38(2-a) of Punjab Procurement Rules 2014. The tender notice inviting bids was got advertised on PPRA's website on 25-03-2016 and in daily Nawai-Waqat Newspapers on 24.03.2016. The last date of receipt of bids was 09.04.2016 (11:00 am). The bids received were opened publically in the presence of bidders on the fix date i.e. 09.04.2016 (11:30 am). The list of participated bidders is as under: -

The meetings of Procurement Committee was held on 09.04.2016 and 18.04.2016 to evaluate responsiveness/technical evaluation of the bidders. The responsiveness of bids received was finalized on the basis of evaluation criteria/required specifications given in the bidding documents. Initially, the result of technical evaluation of bids was announced publically in the meeting of Procurement Committee held on 22.04.2016 at 02:30 pm in the presence of bidders before opening the financial proposals. The envelopes marked as "Financial Proposals" submitted by technically non-responsive firms/bidders were returned un-opened to the representatives of bidding firms.

Secondly, in pursuance of Rule 38(2-a)vi PPR-2014 the financial proposal submitted by technically qualified bidder was opened publically and unit price as well as bid amount quoted by bidder was announced in the presence of bidders. The final evaluation of bids is given on next page.
